**Subject :- Selections for the posts of Garden Assistants/Assistant
Superintendents Garden in Floriculture Department**

Whereas, Agriculture Production Department vide their letter No. TR/56/97/SMG dated 30-01-2006 and No. Agri/Flori/01/2009 dated 29-01-2009 referred 16 and 11 posts respectively of Garden Assistants/Assistant Superintendent Gardens in Floriculture Department; and

Whereas, the Commission vide its Notification No. 04-PSC of 2006 dated: 26-05-2006 and 11-PSC of 2009 dated: 18-03-2009, notified these posts as per the following break-up:-

OM=08, RBA=03, SC=02, ST=02, ALC=01 TOTAL=16 &

OM=07, RBA=01, SC=01, ST=01, SLC=01 TOTAL =11 respectively; and

Whereas, in response to the said notifications the Commission received 1119 applications against Ist Notification and 680 against IInd Notification; AND

Whereas, on the basis of the merit in the Screening test as also the exemption sought for by the candidates as they were possessing higher qualification, according to Rule 40 of JK PSC (Business and Procedure) Rules 1980, 52 and 36 candidates were called for interview against Ist and IInd notifications respectively; and

Whereas, on the basis of overall performance in the interview, academic merit, qualification, experience, special attributes and other relevant factors selection lists were prepared but selections against 1st Notification No. 04-PSC of 2006 dated 26-05-2006 were forwarded to Administrative Department vide letter No. PSC/DR/Garden Assistant/2009 dated: 22-02-2010; and

Whereas, the Commission could not make recommendations in respect of 11 candidates in response to Notification No. 11-PSC of 2009 dated 18-03-2009 due to directions of Hon'ble Court in SWP No. 244/2010 titled Mehraj-Ud Din Ronga & ors Vs State & ors dated: 25-02-2010, CMP No. 213/2010, in SWP No. 2048/2010 titled Mohd Amin Jan & ors Vs State & ors dated 03-02-2010, and CMP No. 3227/2009, in SWP No. 2411/2009 titled Sunil Kakroo & ors Vs State & ors dated: 30-12-2009 for keeping 09 posts reserved. Moreover, there were no specific directions as to which posts are to be kept reserved as these posts belonged to various categories including reserved categories as such the selections in respect of all the 11 posts was kept with held; and

Whereas, the Hon'ble High Court, Division Bench in IA (C) (LPASW No. No. 165/2011 in LPA no. 102/2011, IA (C) Nos 166/2011 and 446/2011 c/w IA (c) Nos. 174/2011, 175/2011 and 176/2011, filed by one Imran Ahmad, vide its directions dated 21-11-2011 has directed as under:-

“Meanwhile, state Govt may take final decision on the recommendations of the Committee in terms of the impugned Writ Court order. The Jammu and Kashmir Public Service Commission is left free to send recommendations on the selection of the Assistant Floriculture Officers to the Government. Those respondents, who are still with the Floriculture Department in terms of Writ Court Order, shall be paid their wages by the State respondents.”

Now, therefore, in compliance of the above directions of the Hon'ble Court Division Bench, the result of 11 with-held posts of Garden Assistant/Assistant Superintendent Garden in Floriculture Department for which selections have been made by the Commission is declared as under:-
