This is for the information of the candidates who have applied for the Combined Competitive (Mains) Examination, 2011 in response to Notification No.PSC/Exm-11/120 dated 04.10.2011 that on scrutiny of the Application Forms data, certain deficiencies/discrepancies have been noticed in respect of certain candidates. Some candidates have left optional subject column blank, some candidates have indicated wrong Roll Nos, some have not indicated their service PREFERENCE COLUMNS and one candidate has chosen wrong combination of optional subjects.

The discrepancies have been examined carefully in the Commission, and it has been decided that the candidates whose forms are deficient of certain information as also indicated above be given an opportunity to make good such deficiency within a period of seven days i.e. up to **12.12.2011** either in person or in writing. After expiry of the said period, no further request shall be entertained and incomplete forms in any respect shall be deemed to have been rejected without entering into any further communication with the candidate(s).

The details of the candidates whose forms have been found deficient in any respect are given in Annexure 'A' to this notice with the reason of deficiency etc.
